## LifeWatch Opens Third Call Center in the USA

Neuhausen am Rheinfall/Switzerland and San Francisco/California – LifeWatch AG (SIX Swiss Exchange: LIFE), the leading provider of wireless telemedicine, today announced the opening of its third call center in the USA. The call center's IT infrastructure in San Francisco is fully redundant to ones in Philadelphia and Rosemont. In case of crises or catastrophes, call center services can immediately be transferred from or to the Midwestern or East Cost centers.

"We are very proud of this step. Our success on the West Coast called for the creation of a new call center in San Francisco to be closer to our patients, physicians and business partners," said Yacov Geva, LifeWatch President and CEO. "The regional presence on the West Coast offers them all full access to services provided within their own respective time zones and allows us to strengthen our market position."
